KNOW ALL MEN BY THESE PRESENTS: That, _____

hereby constitutes and appoints: **TRANSIT AIR CARGO**

and its duty authorized representatives;

as a true and lawful agent and attorney of the grantor named above for and in the name, place, and stead of said grantor from this date and in ALL Customs Districts, and in no other name, to make, endorse, sign, declare, or swear to any entry, withdrawal, declaration, certificate, bill of lading, carnet or other document required by law or regulation in connection with the importation, transportation, or exportation of any merchandise shipped or consigned by or to said grantor; to perform any act or condition which may be required by law or regulation in connection with such merchandise; to receive any merchandise deliverable to said grantor;

owners declarations provided for in section 485, Tariff Act of 1930, as amend-ed, or affidavits in con-nection with the entry of merchandise;

To sign and swear to any document and to perform any act that may be necessary or required by law or regulation in connection with the entering, clearing, lading, unlading or operation of any vessel or other means of convey-ance owned or operated by said grantor;

To make endorsements on bills of lading conferring authority to transfer title, make entry or collect drawback, and to make, sign, declare, or swear to any statement, supplemental statement, sched-ule, supplemen-tal schedule, certificate of delivery, certificate of manufac-ture, certifi-cate of manufacture and delivery, abstract of manufactur-ing records, declaration of proprietor on drawback entry, declaration of exporter on drawback entry, or any other affidavit or document which may be required by law or regulation for drawback purposes, regardless of whether such bill of lading, sworn state-ment, schedule, certificate, abstract, declaration, or other affidavit or docu-ment is

To grant powers of attorney on behalf of the principal to licensed brokers in other Customs districts; to receive, endorse and collect checks issued for Customs duty refunds in grantor's name drawn on the Treasurer of the United States; and if the grantor is a non-resident of the United States, to accept service of process on behalf of the grantor;

To sign, seal, and deliver for and as the act of said grantor any bond re-quired by law or regulation in connection with the entry or withdrawal of imported merchandise or merchandise exported with or without benefit of drawback, or in connection with the entry, clearance, lading, unlading or navigation of any vessel or other means of convey-ance owned or operated by said grantor, and any and all bonds which may be voluntarily given and

And generally to transact at the customhouses in any district any and all customs business, including making, signing, and filing of protests under section 514 of the Tariff Act of 1930, in which said grantor is or may be concerned or interested and which may prop-erly be transacted or performed by an agent and attorney, giving to said agent and attor-ney full power and authority to do anything what-ever requisite and necessary to be done in the premises as fully as said grantor could do if present and acting, hereby ratifying and confirming all that the said agent and attorney shall lawfully do by virtue of these presents; the foregoing power of attorney to remain in full force and effect until the _____ day of _____ 19____, or until notice of revocation in writing is duly given to and received by a District Direc-tor of Customs. If the donor of this power of attorney is a partnership, the said power shall in no case have any force or effect after the expiration of 2 years from the date of its execution.
